2.1.1 Keyboard

Migration Manager for Exchange supports standard keyboard navigation and input functions (such as pressing [Tab] to move between input fields), but several areas still require the use of a pointing device

2.1.2 No Keyboard Trap

If keyboard focus can be moved to a component of the page using a keyboard interface, then focus can be moved away from that component using only a keyboard interface, and, if it requires more than unmodified arrow or tab keys or other standard exit methods, the user is advised of the method for moving focus away.

2.1.4 Character Key Shortcuts

If a keyboard shortcut is implemented in content using only letter (including upper- and lower-case letters), punctuation, number, or symbol characters, then either the keyboard shortcut is only active when that component has focus or a mechanism is available to turn the shortcut off or to remap the shortcut to use one or more non-printable keyboard characters (e.g. Ctrl, Alt, etc).

2.2.1 Timing Adjustable

The Migration Manager for Exchange user interface uses a logical tab order through interactive elements such as links and form controls, but several areas require the use of a pointing device.

2.4.4 Link Purpose (In Context)

The purpose of each link can be determined from the link text alone or from the link text
