2.1.1 Keyboard

SOFS 3.9.1 supports Microsoft Windows accessibility features including StickyKeys, FilterKeys, Magnifier, Narrator, and High Contrast

Minor exceptions in SOFS 3.9.1 applications involve limited keyboard access: 1. The tab pages in the application cannot be navigated by using keyboard, including the SQL Tab pages in the Optimizer Window, tab pages in Options Window. 2. The navigation bar buttons appeared in the Preferences Window cannot be selected by using keyboard. Example: In Preferences Window, select the "Optimization", the navigation button on right hand side of the window (including "Intelligence", "Optimization", "Forces" etc) cannot be selected by using keyboard. 3. Buttons that are neither included in the application main menu bar nor assigned

short-cut key cannot be selected by using keyboard. Example: In both SQL Optimizer Window and SQL Scanner Window, the buttons above the Execution Plan control cannot be selected by using keyboard (including "Query Plan", "Information", etc)

2.1.2 No Keyboard Trap

If keyboard focus can be moved to a component of the page using a keyboard interface, then focus can be moved away from that component using only a keyboard interface, and, if it requires more than unmodified arrow or tab keys or other standard exit methods, the user is advised of the method for moving focus away.

2.1.4 Character Key Shortcuts
