2.1.1 Keyboard

Metalogix Backup For SharePoint does not support all standard keyboard functions in all the areas of the console application. Several areas still require the use of a pointing device

2.1.2 No Keyboard Trap

If keyboard focus can be moved to a component of the page using a keyboard interface, then focus can be moved away from that component using only a keyboard interface, and, if it requires more than unmodified arrow or tab keys or other standard exit methods, the user is advised of the method for moving focus away.
